Approval of Minutes

Taxpayers' Federation of Illinois Board of Trustees Meeting Via Zoom December 20, 2023

Board chair Larry Pociask called the meeting to order. A quorum of the Board was present. Minutes of the June 15, 2023 meeting were approved (motion by Brian Walsh, second by Drew Olson).

TFI President Carol Portman briefly described the State's fiscal condition and expectations for the 2024 legislative session.

The Board discussed the progress of the transition from President Portman to newly-elected President-elect Maurice Scholten, and plans for ongoing meetings and outreach to current, former, and potential members, in addition to media, government personnel, and other friends of TFI in the months to come.

The Board then discussed TFI's financial results for the year to-date, projections for the full year and expectations for 2024. The Board adopted a budget for 2024, as proposed by the Executive Committee (motion by Jeff Hummel, second by Eric Fader). The Board also suggested that TFI personnel develop an investment policy, and other topics of discussion for future meetings.

TFI President Portman presented additional updates. A new employee handbook will be going into effect on January 1, 2024. There were no objections to the Statement of Principles and Position Statements for 2024, which were unchanged from those used in 2023. President Portman described a request to file an amicus brief that was still being finalized, as was the 2023 vendor list for the annual Conflict of Interest statement, both of which would be circulated to the Board soon.

With no further business, the meeting was adjourned.

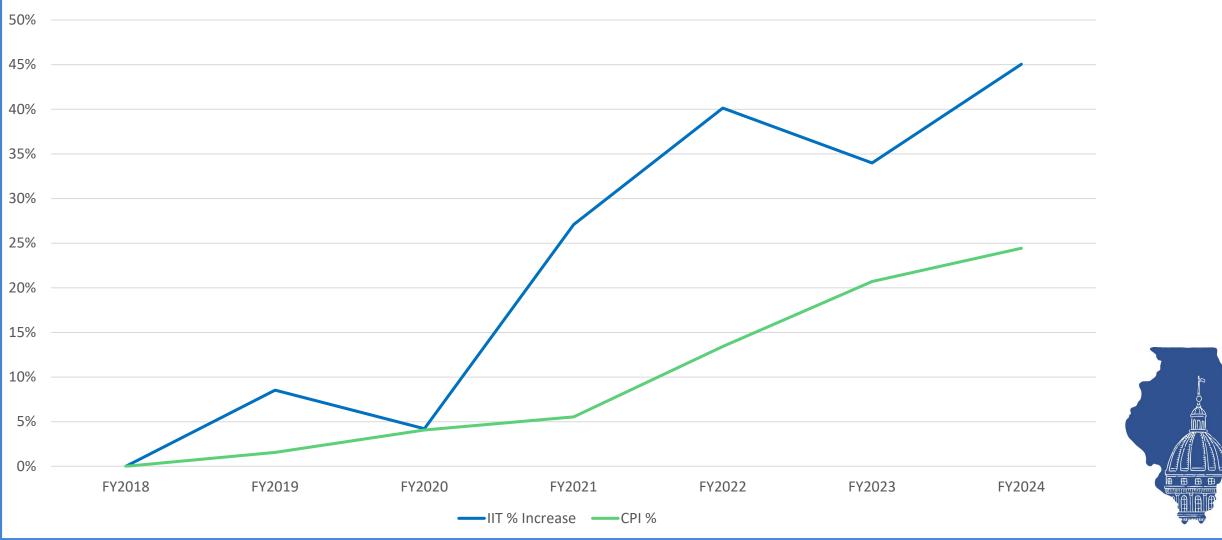
FY2024 Revenue Estimates

 - Big 3 Total +3.0%



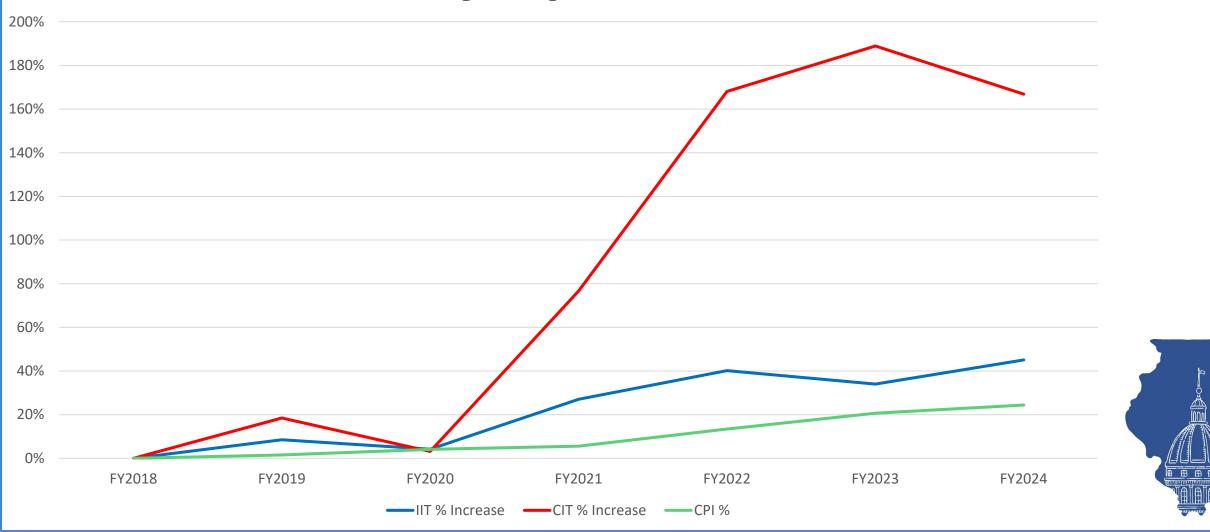
Income Tax Revenues vs CPI

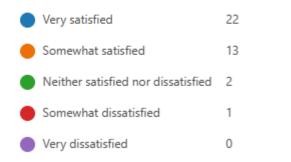

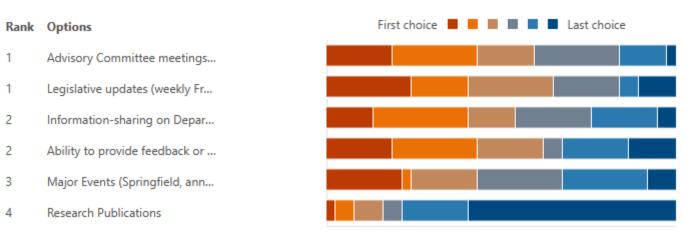
